Terms and Conditions

The Georges Club Mez is a Reward Program operated by Georges Mediterranean Bar & Grill (ABN: 31 049 167 812) as agents for the participating restaurants. The Club is only open to residents of New South Wales who are frequent diners at the participating restaurant; Georges Mediterranean Bar & Grill.

1. To enjoy membership benefits and earn Membership reward points you must be a member.
2. To enroll in the program, the person must complete an application form. This form is available from our website www.georgesrestaurant.com.au and from any of the participating restaurants.
3. To earn reward points, you must quote your membership number when making a reservation and then you must present your membership card when paying the bill at Georges.
4. Reward points are earned on the basis of 1 point per AUD\$1 spent at the participating Georges Restaurant. These points accumulate and can be redeemed for a variety of different rewards. Point redemption will be calculated to the nearest whole dollar for each transaction. Members may earn rewards points on this ratio (\$1 = 1 point) for a maximum of 12 people in any one dining transaction.
5. In the instance that 13 or more guests are dining, the member can earn rewards point yet the ratio is 1 point per AUD\$2 spent.
6. To earn reward points, the Club Mez Member must be paying the bill.
7. In the event Georges Mediterranean Bar & Grill terminates the membership program Georges will not be responsible for advising members of the termination.
8. Reward Points cannot be credited retrospectively and can only be allocated to one account. Once points have been earned and awarded to one Membership Account, they cannot be transferred.
9. **2008-09 Reward Points can be accumulated until 30th June 2009. Validity cannot be extended under any circumstance.**
10. Members have up until the 30st September 2009 to redeem 2008-09 points. After this date, members can no longer redeem the previous year's points.
11. To redeem a reward please call **9295 5044**, Monday-Friday during office hours. We require a minimum of two weeks (2) notice to arrange your rewards to be picked up or vouchers to be sent.
12. Membership privileges will only be extended to the Club Mez Members. Members must identify themselves to the restaurant staff on arrival by providing their Membership Number. Identification via your Membership Number is essential for accurate point tracking purposes.
13. Membership benefits are non transferable, unless you have enrolled as a Georges Corporate Club Member. In regards to Corporate Club Members, Georges requests that **one nominated person** within the organisation manages all restaurant reservations and reward redemptions. All communication from Georges will be sent to the nominated person within the organisation. Only one set of rewards will be offered per Membership at any one meal sitting.
14. Due to privacy laws, individual account information, including reward redemption details will not be given to anyone other than the member whose name appears on the account. This information will be delivered to the address recorded on the account at the time of the request.
15. Federal, state or other taxes resulting from reward points earned or redeemed are the sole responsibility of the member.
16. Each member will be assigned a unique Membership Number, which must be quoted at the time of each booking or reward redemption.
17. Georges reserves the right to cancel a Membership at any time if it appears that the Membership is being used in any other way than which the program is designed.
18. Georges reserves the right to change, limit, add or delete any of the program rules, terms, conditions, benefits, reward levels, in whole or in part, at any time, as its sole discretion, with or without notice. Members may not rely upon the continued availability of any reward or reward level. Members may not be able to obtain all offered rewards or use rewards at all participating restaurants. If the program is cancelled at any time, all points at the time of cancellation will be forfeited.
19. The program has no predetermined lifespan and may continue until such time as Georges Mediterranean Bar & Grill, in its sole discretion, elects to designate a termination date.
20. Other than as provided herein neither the program nor any benefit offering or the like relating to the program shall be construed as or constitute a contract or otherwise establish a contractual relationship between Georges Mediterranean Bar & Grill and the member.
21. It is the individual member's responsibility to notify the Club of any change in address details. If we are unable to contact a member within a 6-month period, we reserve the right to close the Membership account. All points in credit at that time will be forfeited.
22. There is no limit to the number of members per table who are able to earn points for a single visit to Georges. Each member will earn points for the share of the dining transaction that they personally pay for.
23. Only one reward can be redeemed at any one time and cannot be used in conjunction with any other offer.
24. If you wish to terminate your Club Mez membership please advise Georges in writing and we will remove your details from our membership database.
